
PUBLIC CONSULTATION ON PROPOSED MULTIVERSITY CAMPUS MIXED-USE DEVELOPMENT, TALBOT GATEWAY

Blackpool Council (in partnership with Blackpool and the Fylde College) would like to invite you to participate in its public consultation event on plans for a new education-led mixed-use development on land bound by George Street, Grosvenor Street, Milbourne Street and Cookson Street (the Site), at Talbot Gateway. The proposal is for a new 'Multiversity' higher education campus, commercial office space, high quality public realm and landscaping, following the demolition of existing buildings.







Summary of the Proposals

Blackpool Council (In partnership with Blackpool and the Fylde College) have secured £40m in funding from Government to deliver a new higher education campus in Blackpool's Talbot Gateway Central Business District.

The proposals would transform this area of the Town Centre by creating attractive new buildings with landscaped public realm and tree planting following the demolition of existing buildings across the Site.

The 'Multiversity' is intended to bring up to 3,000 staff and students into the town centre. It aims to promote higher-level skills, helping residents in Blackpool secure jobs for the future. The Multiversity will provide a range of educational facilities including a Business School, Digital Hub, an Innovation Hub and a large area of general teaching space. The second phase of development would also provide new offices and potentially small scale retail and

leisure uses such as cafes and restaurants, creating new jobs for the town.

The next step in the development of the Multiversity is the submission of an outline planning application. This outlines the main use of the site as an educational-led development and sets conditions on the size of the buildings, including its height and footprint. The proposed development is 5 storeys at its highest, near the Council offices, stepping down to 3 storeys adjacent to nearby houses along Grosvenor Street and Milbourne Street.

In summary the proposal will: redevelop the Site with high quality buildings in an area which is a key regeneration priority for the Council. It will deliver a new education facility and office space for Blackpool, creating jobs, and will deliver new public realm and tree planting for the enjoyment of residents and visitors to the town.
